

CONTRIBUTING CONTENT AGREEMENT

This Contributing Content License Agreement (the “Agreement”) is entered into as of _____, 20__ between AHE, a PMG of the American Hospital Association, an Illinois not-for-profit company (the “Organization”) and _____ (“You”) regarding Your original content submitted to the Organization at any time (the “Content”). For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, You agree as follows:

Thank you for agreeing to develop and contribute Content for FAHE. Content may include, but is not limited to, written, pictorial, electronic, graphical, tabular, audio, video or other content. You agree to deliver to the Organization a complete copy of the Content in a format requested by the Organization. The Organization may return the Content to You for revisions. You understand that the Organization may need to edit, translate or otherwise modify the Content to conform to the Organization’s editorial standards, and You hereby authorize the Organization to make such edits, translation or modification to the Content.

You understand and agree that the Organization and its affiliates shall own all copyrights and other intellectual property rights to the Content, including the right to register the Content. You hereby assign to the Organization and its affiliates all right, title and interest in and to the Content, including all copyrights therein, and will not challenge the Organization’s ownership thereof. In the event that the Organization elects to make audio and/or video recordings of You delivering/performing the Content, You agree that the recordings shall be deemed “Content” also and Organization shall own all rights in such recordings. If You become aware of any infringing or unauthorized use of the Content, You agree to promptly notify the Organization and cooperate in any investigation of the infringing or unauthorized use. You agree not to reproduce, republish, or distribute the Content in any manner without the Organization’s prior written consent. Where the Organization grants its approval, You agree to include the citations specified by the Organization and provide the Organization with a copy of the final publication.

You agree that if the Organization publishes, displays or otherwise distributes the Content or recordings thereof, the Organization may use Your name, biography, likeness and performance in connection with the Organization’s use of the Content and related recordings, including in advertising, publicity and promotion. You also understand that publication of the Content is at the Organization’s discretion and it is possible that the Organization may not publish the Content.

The Organization is relying on You to deliver original Content. Accordingly, please do not provide any Content that is a result of copying the content of others or that infringes on the privacy rights of others. You represent that the Content is Your original work and does not infringe upon any copyright or any other right whatsoever of any other person or entity, and that You have full power and authority to enter into this Agreement.

You understand that the Organization may discontinue this Agreement immediately upon written notice to You. You understand and agree that this Agreement does not create any employment, agency, partnership, or co-venturer relationship between you and the Organization. This Agreement constitutes the entire Agreement between You and the Organization with respect to the Content and may not be modified except by written agreement of both parties.
