

2026 AHE Member Needs Survey Sweepstakes

Official Rules

NO PURCHASE NECESSARY. VOID WHERE PROHIBITED.

Participation in the 2026 AHE Member Needs Survey Sweepstakes (the “Sweepstakes”) constitutes agreement to these Official Rules, which are a binding contract. Please read carefully.

1. Sponsor

Association for the Health Care Environment (AHE), an affiliate of the American Hospital Association (“Sponsor”).

2. Sweepstakes Period

The Sweepstakes begins **[June 22, 2026] at 12:01 a.m. Central Time** and ends **[July 22, 2026] at 11:59 p.m. Central Time** (“Sweepstakes Period”). Sponsor’s system clock is the official timekeeper.

3. Eligibility

Open to legal residents of the **50 United States or the District of Columbia** who are **18 years of age or older** at the time of entry. Void in Puerto Rico, Guam, other U.S. territories and possessions, and where prohibited by law.

Employees of Sponsor and its affiliates, and their immediate family members (spouse, parent, child, sibling) or household members, are not eligible. All federal, state, and local laws apply.

4. How to Enter

To enter, complete the **2026 AHE Member Needs Survey** during the Sweepstakes Period. Upon completion, you will automatically receive **one (1) entry** into the Sweepstakes.

- Limit: one (1) entry per person
- Automated, scripted, or fraudulent entries are void
- All entries become the property of Sponsor and will not be acknowledged or returned

5. Prizes and Odds

Prizes:

- Five (5) **\$100 Amazon e-gift cards**

Total Approximate Retail Value (ARV): \$500

Odds: Odds of winning depend on the total number of eligible entries received.

6. Winner Selection and Notification

Five (5) winners will be selected in random drawings conducted by Sponsor on or about **[July 31, 2026]** from all eligible entries.

Potential winners will be notified by email and may be required to complete an eligibility and liability release within seven (7) days of notification.

- Limit one (1) prize per person or household
- Prizes are non-transferable and have no cash equivalent
- Sponsor reserves the right to substitute a prize of equal or greater value
- Prizes will be delivered electronically

Failure to respond or comply with these Official Rules may result in forfeiture and selection of an alternate winner.

7. Taxes

Winners are solely responsible for any federal, state, or local taxes associated with acceptance or use of a prize.

8. Privacy and Use of Survey Responses

Sponsor is not responsible for late, lost, incomplete, inaccurate, misdirected, or technically corrupted entries, or for any errors or failures related to participation. Sponsor reserves the right to modify, suspend, or cancel the Sweepstakes if its integrity or fairness is compromised.

10. Limitation of Liability

By participating, entrants release and hold harmless Sponsor and its affiliates from any claims or damages arising from participation in the Sweepstakes or acceptance or use of any prize. Prizes are awarded "as is," without warranty of any kind.

11. Disputes and Governing Law

All disputes arising from the Sweepstakes shall be resolved **individually**, without class action, and governed by the laws of the **State of Illinois**. Disputes shall be resolved through binding arbitration or, where permitted, in courts located in Cook County, Illinois.
